### Terms and Conditions

1. Payment is expected at time of service—cash, approved check, credit card or ATM/debit card used as a credit card unless other arrangement have been agreed to in advance. A 5% charge will be added for credit or debit cards for the recovery of processing and transaction fees charged to Farrier Art. We will accept checks but only with the backup of a credit card on file with Farrier Art. There is a \$30 fee for checks returned for insufficient funds, and your credit card on file will be charged the balance due.
2. Someone must be available to catch and hold the horses and to present payment unless other arrangements have been agreed to in advance.
3. The location must be a safe, clean, flat, dry, and well-lighted place to work.
4. Horses must be trained and well mannered. Additional charges will be added if physical restraint is necessary. I will stop work if horses present a safety hazard to themselves or anyone in the area. Veterinary services to administer chemical restraint must be arranged for in advance. If work has to be halted because of the horse's behavior, you will be charged for the added time. You will be charged time and materials for repairing or if necessary for replacing damaged equipment and tools caused by your horse.
5. A 24-hour notice prior to appointment must be given for any appointment changes. This includes: Adding or subtracting horses from the appointments schedule, changing what is scheduled to be done to the horse(s), canceling an appointment, etc. Within 24-hours of your appointment time, a change fee of \$120.00 may apply.
6. Unless another arrangement is agreed to in advance, the first 15 miles of travel are free. After that, a mileage fee of \$4.00 per mile, one-way will be charged. A 50 mile trip would therefore add a flat-charge of \$140.00, regardless of the number of horses being serviced. Bridge tolls are not included and will be charged.

The cardholder attests that the above information is correct, that he/she has read and understands the above Terms and Conditions, and that he/she consents to the use of his/her credit card in payment of appropriate invoices, according to the terms and conditions of the issuer.
